

COOKIE POLICY

LAST UPDATED: JANUARY 12, 2026

This Cookie Policy explains how EMYO LIMITED (“we”, “us”, “our”, “Emyo” or the “Company”), collects and uses cookies and similar technologies (“Cookies”) to recognise you when you visit our website and platform.

It explains what these technologies are and why we use them, as well as your rights to control our use of them. In some cases, we may use cookies to collect Personal Data, or that becomes Personal Data if we combine it with other information.

1. WHAT ARE COOKIES

1.1 Third parties serve Cookies through our site and/or platform for advertising, analytics, and other purposes. This is described in more detail below. Cookies are small text files stored on your device that allow the website and platform to function correctly, remember your preferences, enhance performance, and help us understand how our services are used. Users may manage Cookie preferences through their browser.

1.2 Certain cookies expire after different periods and triggers. Generally, cookies are either:

- (a) Session Cookies. These are temporary cookies that expire when you close your browser. They help maintain your session during your visit;
- (b) Persistent Cookies. These cookies remain on your device for a specified period. They remember your preferences across visits.

1.3 We use first- and third-party Cookies for several reasons. Some Cookies are required for technical reasons in order for our site and/or platform to operate, and we refer to these as “essential” or “strictly necessary” Cookies. Other cookies also enable us to track and target the interests of our users to enhance the experience on our site and/or platform.

1.4 Third parties serve cookies through our site and/or platform for advertising, analytics, and other purposes. This is described in more detail below.

2. YOUR CHOICE

2.1 Before using any Cookies (except strictly necessary ones), we obtain your consent. You can manage your Cookie preferences through your browser settings.

2.2 Your Cookie settings allow you to select which categories of Cookies you accept or reject. Essential Cookies cannot be rejected as they are strictly necessary to provide you with Services. If you choose to reject Cookies, you may still use our website though your access to some functionality and areas of our website may be restricted. You may also set or amend your web browser controls to accept or refuse Cookies.

3. DIFFERENT TYPES OF COOKIES

3.1 **Necessary cookies.** These Cookies are strictly necessary to provide you with Services available through our Site and/or platform and to use some of its features, such as access to secure areas. These Cookies are essential for the website to function properly. They enable basic features such as page navigation.

3.2 **Analytics cookies.** These Cookies are used to enhance the performance and functionality of our site and/or Platform but are non-essential to their use. However, without these Cookies, certain

functionality (like videos) may become unavailable. These Cookies enhance your experience for example by remembering your preferences (e.g., language, region) and providing personalised features. We also use these Cookies to collect anonymous data about how visitors use our website and platform. This helps us improve site performance and optimise content.

3.3 Advertising cookies. These cookies are used to make advertising messages more relevant to you. They perform functions like preventing the same ad from continuously reappearing, ensuring that ads are properly displayed for advertisers, and in some cases selecting advertisements that are based on your interests. These cookies track your browsing habits and allow us to show you relevant ads.

3.4 Websites may also use so-called “**Flash Cookies**” (also known as **local Shared Objects** or “**LSOs**”) to, among other things, collect and store information about your use of our Services, fraud prevention, and for other site operations. If you do not want Flash Cookies stored on your computer, you can adjust the settings of your Flash player to block Flash Cookies storage using the tools contained in the Website Storage Settings Panel. You can also control Flash Cookies by going to the Global Storage Settings Panel and following the instructions (which may include instructions that explain, for example, how to delete existing Flash Cookies (referred to “information” on the Macromedia site), how to prevent Flash LSOs from being placed on your computer without your being asked, and (for Flash Player 8 and later) how to block Flash Cookies that are not being delivered by the operator of the page you are on at the time). Please note that setting the Flash Player to restrict or limit acceptance of Flash Cookies may reduce or impede the functionality of some Flash applications, including, potentially, Flash applications used in connection with our services or online content.

4. HOW TO CONTROL COOKIES

4.1 As the means by which you can refuse cookies through your web browser controls vary from browser to browser, you should visit your browser’s help menu for more information. We operate a cookie consent mechanism tool for you to manage your preferences, which you may use to change your mind on Cookies, or obtain further detail. You access it via the icon at the foot of each webpage or via the pop-up Cookies banner.

5. LINK TO OTHER WEBSITES

5.1 Our website may contain links to other websites of interest. However, once you have used these links to leave our site, you should note that we do not have any control over that other website. Therefore, we cannot be responsible for the protection and privacy of any information which you provide whilst visiting such sites and such sites are not governed by this privacy statement. You should exercise caution and look at the privacy statement applicable to the website in question.

6. CHANGES TO THE COOKIE POLICY

6.1 We may update this Cookies Policy from time to time in order to reflect, for example, changes to the cookies we use or for other operational, legal, or regulatory reasons. Please therefore revisit this Cookies Policy regularly to stay informed about our use of Cookies and related technologies.
